5	<b>Notification obligation regarding rectification or erasure of personal data or restriction of processing</b> (GDPR 679/2016, article 19)	Obligation of QMS, if requested. QMS (data controller) informs the data of subject, if requested by the data of subject (GDPR 679/2016, article 19).	
6	<b>Right to data portability</b> (GDPR 679/2016, article 20)	Obligation of QMS, if requested. This right is exercised with the prejudice to article 17 (GKPD 679/2016, article 20, paragraph 3)	
7	<b>Right to object</b> (GDPR 679/2016, article 21)	Obligation of QMS, if requested. This right is exercised with the prejudice (GKPD 679/2016, article 21, paragraph 1).	
8	<b>Automated individual decision-making, including profiling</b> (GDPR 679/2016, article 22)	Obligation of QMS, if requested. This obligation does not apply on a case may be, as mentioned in GDPR 679/2016, article 22, par. 2, items a, b and c, and par. 3 and 4.
